No Proposals will be accepted after said hour. The contract Scope of Work will include three (3) buildings in the Borough: Vermeule Mansion (Project A); North Plainfield Public Library (Project B); and Vermeule Community Center (Projects C & D). As a means to prepare for and prevent the spread of the novel coronavirus, Projects A, B, and C include interior improvements and HVAC system upgrades to toilet rooms and meeting spaces. Project D includes exterior work via the creation of an outdoor paved plaza featuring a partially covered porch, exterior seating, landscaping, and site drainage. The contract will allow one hundred fifty (150) calendar days for completion of the work from the Notice to Proceed. Notice to Proceed will be issued on or about May 13, 2022. A pre-bid meeting will be held on **Tuesday**, **April 12**, **2022**, **at 11 A.M.**, at the Vermeule Community Center. This meeting is not mandatory, but it is strongly recommended that all interested bidders attend.

Proposals shall be made on the forms provided and made part of the Contract Documents, which shall be submitted intact. A certified check or cashier's check made payable to the order of the Borough of North Plainfield, or a duly executed Bid Bond, in the amount of ten (10) percent (%) of each bid, but in no case in excess of \$20,000.00 must be deposited by the Bidder together with a Surety Consent evidencing that he can obtain the required Performance Bond.

The successful Bidder shall be required to comply with requirements of <u>N.J.S.A.</u> 10:5-31 et seq. and <u>N.J.A.C.</u> 17:27, and deliver to the Borough an executed Performance Bond of a responsible indemnity company authorized to do business in the State of New Jersey.
