MINUTES of the Regular (virtual) Meeting of the Council of the Borough of North Plainfield held on Monday, **July 12, 2021** at 8:22 p.m. via Zoom.

Mr. Phoenix read the following Notice of Compliance:

The Clerk had submitted copies of the minutes of the Board of Health, Agenda Conference and Regular Meeting of June 28, 2021.

The Council Vice President called for a Roll Call on the minutes: All five in favor.

ORDINANCE NO. 21-05 AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT CHAPTER 22, "LAND DEVELOPMENT", § 22-115, ENTITLED "GENERAL PROVISIONS," MOST NOTABLY AMENDING, REVISING AND SUPPLEMENTING § 22-115 BY ADDING § 22-115.33, ENTITLED "COMMERCIAL RECREATIONAL ADULT USE CANNABIS OPERATIONS," PERMITTING CERTAIN CLASSES OF CANNABIS BUSINESSES IN SPECIFIED ZONES WITHIN THE GEOGRAPHICAL BOUNDARIES OF THE BOROUGH OF NORTH PLAINFIELD.

The Clerk read the ordinance by its title.

PUBLIC COMMENT:

Mercedes Mejia, 94 Fairview Avenue, North Plainfield, asked if the ordinance would approve the sales of cannabis in town. Mr. Merrill explained that it had been initially approved by a vote of 5-2 at a prior meeting. Mr. George reported on the Council's ad-hoc committee examining the matter. The ordinance is responsive to the findings of the committee. Certain zones along Route 22 will allow for sales from recreational cannabis retailers. Mr. Merrill added that subcommittee members on the topic had worked diligently. In the survey, between 70-75% of respondents were in favor.

Motion to close public comment by Ms. Corzo, seconded by Ms. Given and on Roll Call carried all five voting aye.

PUBLIC COMMENT:

Mercedes Mejia, 94 Fairview Avenue, North Plainfield, asked if the ordinance would allow people to smoke indoors but not outdoors. Mr. McIntyre explained that the ordinance extends prohibitions on public cannabis smoking to include public areas, restaurants and school perimeters to the same banned areas for tobacco smoking. Cannabis smoking would not be allowed in restaurants, for example, since tobacco smoking bans are already in place in those areas.

Motion to close public comment by Ms. Corzo, seconded by Ms. Given and on Roll Call carried all five voting aye.

RESOLUTION NO. 07-12-21-08a RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE MAYOR AND BOROUGH CLERK TO ACCEPT A PROPOSAL IN THE AMOUNT OF \$119,400.00 SUBMITTED BY CTS GROUP ARCHITECTURE PLANNING, P.A. RELATED TO THE ARCHITECTURAL DESIGN SERVICES PERTAINING TO BUILDING IMPROVEMENTS TO PREVENT THE SPREAD OF THE COVID-19 VIRUS WHEREAS, the Borough of North Plainfield is in need of certain improvements to Municipal Buildings throughout the Borough as part of an effort to prevent the spread of the novel coronavirus; and,

WHEREAS, the Borough of North Plainfield has received a proposal from CTS Group Architectural Planning, PA to design the plan and oversee the improvements to the Vermeule Mansion at 614 Greenbrook Road, the North Plainfield Memorial Library at 6 Rockview Avenue, and the Vermeule Community Center at 614 Greenbrook Road related to the 2019 CDBG-CV3 Public Facilities Project; and,

WHEREAS, CTS has submitted a total proposal in the amount of One Hundred Nineteen Thousand Four Hundred (\$119,400.00) Dollars to design and oversee the project as set forth below; and,

WHEREAS, Vermeule Mansion Improvements in the non-historic toilet rooms will include; ADA Improvements to the bathroom, installation of one (1) touchless faucet, installation of one (1) touchless flush valve on toilet, installation of one (1) touchless soap dispenser, installation of one (1) touchless paper towel dispenser, installation of one (1) hand sanitizer station; and,

WHEREAS, the Vermeule Mansion Improvements to the kitchen will include the installation of one (1) touchless faucet, one (1) hand sanitizer and one (1) touchless paper towel dispenser; and,

WHEREAS, the improvements to the North Plainfield Memorial Library will include the following improvements to various toilet rooms; installation of even (7) touchless faucets, installation of two (2) touchless valves on urinals, installation of touchless flush valves on toilets (as applicable), installation of three (3) touchless soap dispensers, installation of two (2) hand sanitizer stations, installation of four (4) light switch sensors/timers on bathroom light switches, and fresh air intake/exhaust on large gathering areas located in the Main Library/Children's Collection, First Floor Conference room and the Lower Level Meeting Room; and,

WHEREAS, the Vermeule Community Center Restroom Improvements will include the installation of; twenty-one (21) touchless faucets in all toilet rooms and meeting rooms, nine (9) touchless flush valves on urinals and toilets, fifteen (15) touchless flush valves on toilets, twenty-one (21) touchless soap dispensers and paper towel dispensers, seven (7) touchless paper towel dispensers, three (3) hand sanitizer stations and new bathroom toilet/urinal partitions; and,

WHEREAS, the Vermeule Community Center Building Retrofit will include the installation of the addition of exhaust/fresh air for building meeting rooms, outdoor plaza space with permanent paved surface, Accessibility to the plaza area from the doors that exit the building, combination of permanent and temporary seating areas outside the building, availability of utility connections for electric and access to Wi-Fi connections, exterior site lighting via building mounted light fixtures and/or site bollards, and landscaped areas and a potential area for a rain garden for site drainage; and;

WHEREAS, the Contract Design Documents will focus on the design for all of these projects to provide equipment to help prevent the spread of germs and viruses, especially in this COVID-19 pandemic world. The design features will include touchless plumbing fixtures, dispensers and hand sanitizer stations, as well as upgrades to the existing toilet rooms and improvements to the fresh air/exhaust systems. Other improvements will include an outdoor paved patio, seating area with landscaping and rain garden; and,

WHEREAS, the design services will include meeting with the Borough to discuss design objectives for an outdoor patio and seating area, the preparation of one (1) set of drawing documents as required for construction, with one (1) cover sheet and floor plans, reflected ceiling plans with interior elevations as necessary for all projects, color selections, equipment selections and schedules as necessary and one (1) full set of set specifications that will apply to all projects; and,

WHEREAS, the design services will <u>not</u> include hazardous materials investigation, abatement, or remediation, color and fabric selection boards, interior design services, 3D digital renderings, building system commissioning, an assessment report of the existing buildings and/or recommendations to upgrade or bring in compliance to be considered a disaster-resistant structure; and,

WHEREAS, the basis for compensation to CTS Group as to the design services to be provided are as follows;

WHEREAS, if the Borough and CTS Group Architectural Planning, PA agree that more extensive representation at any of the sites by CTS Group than that described herein, as an additional service, compensation for those additional services will be based on the hourly rates set forth in the CTS Group Proposal, dated June 24, 2021 attached hereto; and,

WHEREAS, invoices will be issued monthly and will include reimbursable expenses (reproductions costs, mailing, deliveries, etc.) which are outside of basic compensation; and,

WHEREAS, the CTS Group design team will be available to commence work on the aforesaid project starting in mid July of 2021. It is expected that the interior design phase will take approximately sixty (60) calendar days; and,

WHEREAS, the amount of time needed to design the exterior work is a function of survey scheduling, more information will be provided upon execution of agreement between the parties; and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby accepts the proposal submitted by CTS Group Architectural Planning, PA ("CTS Group") in the amount of One Hundred Nineteen Thousand Four Hundred (\$119,400.00) Dollars in accordance with the Proposal submitted by CTS Group dated June 24, 2021, and attached hereto as if made a part of this Resolution; and,

BE IT FURTHER RESOLVED that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute any and all other necessary documents related to the acceptance of this Proposal and Payment for the services CTS Group Architectural Planning PA, LLC, for Building Improvement Projects as set forth above; and,

WHEREAS, the Borough of North Plainfield is in need of certain improvements to roadways throughout the Borough as part of the 2019 Capital Road Improvement Program; and,

WHEREAS, the Borough of North Plainfield has entered into an agreement with Cifelli and Son General Construction, LLC to perform the work related to the 2019 NJDOT Grandview Avenue Road Improvements Project; and,

WHEREAS, the Borough of North Plainfield has received a recommendation from Grotto Engineering Associates, LLC, its Borough Engineer, to accept a change order in the amount of \$9,163.35 received from Cifelli and Son General Construction, LLC., to resolve all final unit quantities and police traffic control invoices; and,

WHEREAS, said change order also includes charges for minor overruns on the police traffic control time resulting in the total adjusted contract amount of \$390,567.60; and,

WHEREAS, Cifelli & Son General Construction, LLC have also submitted a one (1) year maintenance bond in the amount of \$39,056.76, with an effective date of May 31, 2021, with certified payroll reports and invoices for the change order and final payment, which are attached hereto and made part of this resolution; and,

WHEREAS, Grotto Engineering Associates, LLC recommends that final payment be issued to Cifelli and Son General Construction, LLC in the amount of \$223,780.40, which represents the second (2nd) and final payment relating to this project; and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby accepts Change Order No. 1 in the amount of \$9,163.35 and approve Payment No. 2 as the final payment in the amount of \$233,780.40 in accordance with the recommendation made by Grotto Engineering Associates LLC,

Bernstein & Associates, LLC, as well as Grotto Engineering Associates, LLC, the Borough's Engineer on the Project, have reviewed the bid submissions and recommend the award of the bid and contract for the Project to the lowest responsive and responsible bidder, Cifelli & Son General Construction, Inc., whose main offices are located at 4 Coppola Street, Nutley, NJ 07110 (hereinafter referred to as the "Contractor"), as there are no material defects with the bid proposal; and,

WHEREAS, the Borough of North Plainfield is desirous of obtaining the services of the Contractor to perform all those services contemplated in the Borough's bid documents and the bid proposal submitted by the Contractor; and,

WHEREAS, the Borough of North Plainfield finds that the Contractor is the lowest responsive and responsible bidder for the Project, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.
