- I, PATRICK J. DEBLASIO, Chief Financial Officer of the Borough of North Plainfield, in the County of Somerset, State of New Jersey (the "Borough"), make the following certification pursuant to the provisions of N.J.S.A. 40A:4-54 through 55. Accordingly, I DO HEREBY CERTIFY to the following:
- Purpose of Emergency Appropriation The Borough Council of the Borough of North Plainfield, in the County of Somerset, State New Jersey (the "Borough") has found it necessary to make a special emergency appropriation of not to exceed \$800,000 to cover the cost of extraordinary expenses for the repair, reconstruction of streets, roads, bridges, or other public property damaged by floods and severe weather conditions caused by Tropical Storm Ida (the "Project"), which extraordinary expenses were not foreseen at the time of the adoption of the Borough's 2021 budget, such improvement or purpose shall also include the following, as applicable, engineering, design and site work, preparation of plans and specifications, permits, bid documents, contract administration and also all work, materials, equipment, labor and appurtenances as necessary therefor or incidental thereto (the "Obligation") by the Borough. The total cost to the Borough of the Obligation was not a known or foreseen amount at the time of the adoption of the current fiscal year's budget and an adequate provision for such cost was not made in said budget. Due to the fact that no adequate provision was made in the budget for the year ended December 31, 2021 for the aforesaid purpose, N.J.S.A. 40A:4-54 provides for the creation of a special emergency appropriation via the adoption of a resolution for the aforesaid purpose.
- 2. <u>Contracts</u> No Contracts have been awarded or purchase orders placed in connection with this special emergency appropriation.
- 3. <u>Special Emergency Notes Authorized</u> Resolutions will be considered by the Borough Council of the Borough that will authorize said special emergency appropriation for extraordinary expenses in the amount of \$800,000 and will also authorize the sale and issuance of \$800,000 aggregate principal amount of Special Emergency Notes to temporarily finance the cost of the special emergency appropriation.

WHEREAS, Tropical Storm Ida caused severe weather conditions and flooding in New Jersey for which Governor Murphy declared a state of emergency pursuant to Executive Order 259; and

WHEREAS, the Borough of North Plainfield, in the County of Somerset, State of New Jersey (the "Borough") suffered severe flooding and damages from Tropical Storm Ida; and

WHEREAS, pursuant to the provisions of N.J.S.A. 40A:4-54, on September 13, 2021, the Borough Council of the Borough adopted a resolution authorizing a special emergency appropriation in the amount of \$800,000 to cover the cost of extraordinary expenses for the repair, reconstruction of streets, roads, bridges, or other public property damaged by floods and severe weather conditions caused by Tropical Storm Ida (the "Project"), which extraordinary expenses were not foreseen at the time of the adoption of the Borough's 2021 budget; and

WHEREAS, N.J.S.A. 40A:4-55 allows "special emergency notes" (the "Notes") to be issued to finance the costs of such Project, which payment for such Notes shall be provided for in the succeeding annual budgets of the Borough by the inclusion of an appropriation of at least one-fifth (1/5) of the amount of such Notes; and

WHEREAS, the Borough now seeks to authorize the issuance of Notes in an amount not to exceed \$800,000.

NOW, THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF NORTH PLAINFIELD, IN THE COUNTY OF SOMERSET, STATE OF NEW JERSEY (by not less than 2/3 of all governing body members affirmatively concurring) that in accordance with the provisions of N.J.S.A. 40A:4-55, as follows:

SECTION 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

SECTION 2. The Borough authorized a special emergency appropriation in an amount equal to \$800,000 in accordance with N.J.S.A. 40A:4-54.

SECTION 3. Special emergency notes (the "Notes") in an amount not to exceed \$800,000 are hereby authorized, pursuant to N.J.S.A. 40A:4-55, to finance such special emergency appropriation.

SECTION 4. Such Notes may be renewed from time to time in accordance with N.J.S.A. 40A:4-55, but shall not be issued for a period to exceed one year. At least 1/5 of all such Notes, and the renewals thereof, shall mature and be paid in each year beginning in 2022 so that all Notes and renewals shall have matured and be paid no later than the last day of the fifth year following the date of this resolution.

SECTION 5. Such Notes shall be executed by the manual or facsimile signatures of the Mayor and the Chief Financial Officer of the Borough and the official seal shall be thereunto affixed, imprinted or reproduced thereon and attested by the Clerk of the Borough.

SECTION 6. All Notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Borough. The Notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. It is hereby delegated to the Chief Financial Officer of the Borough the authority to determine all matters in connection with the Notes issued, and the signature of the Chief Financial Officer upon the Notes shall be conclusive evidence as to all such determinations. The Chief Financial Officer is also hereby authorized to sell part or all of the Notes from time to time at a public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the Notes pursuant to this resolution is made. Such report must include the principal amount, the description, the interest rate, the maturity schedule of the Notes so sold, the price obtained and the name of the purchaser.

SECTION 7. One (1) certified copy of this resolution shall be filed with the Director.

SECTION 8. This resolution shall take effect immediately.
