RESOLUTION NO. 10-24-22-02a RESOLUTION OF THE BOROUGH COUNCIL REJECTING ALL BIDS FOR A NEW PUBLIC COURTYARD AT VERMEULE COMMUNITY CENTER.

WHEREAS, the Borough of North Plainfield (hereinafter referred to as the "Borough") is in need of certain improvements for the construction of a new public courtyard at the Vermeule Community Center (hereinafter referred to as the "Project"); and,

WHEREAS, the Borough solicited bids for the Project and the following five (5) bids were received:

WHEREAS, upon review of the apparent lowest bid of Whirl Construction, Inc., by CTS Group Architecture & Planning, P.A., the Borough's Architect on the Project (the "Architect"), by letter dated September 16, 2022, a copy of which is on file in the office of the Borough Clerk, some clerical mathematical errors were noted and specific line item information regarding pricing was not included; and,

WHEREAS, furthermore, the review of the base bid of Whirl Construction, Inc. in the amount of Four Hundred Seventy Thousand Eight Hundred and Fifty One Dollars and No Cents (\$470,851.00) was found to be approximately twenty one percent (21%) over the Architect's estimate for the Project; and,

WHEREAS, the Architect noted that while volatile market conditions may have resulted in higher prices which may be reflected in the prices set forth in the bid of Whirl Construction, Inc., the fact is the that the apparent lowest bid is approximately twenty one percent (21%) higher than the Architect's estimate, some clerical mathematical errors were noted and specific line item information regarding pricing was not included and that, upon review, the base bid price is not fair nor reasonable and should be rejected; and,

WHEREAS, the next lowest and bid received from Salazar Associates, Inc., in the amount of Five Hundred Forty Six Thousand Nine Hundred Dollars (\$546,900.00) was more than One Hundred and Fifty Thousand Dollars (\$150,000.00) over the Architect's estimate and all other bids were more excessive; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esquire and the offices of Eric M. Bernstein & Associates, L.L.C., as well as CTS Group Architecture & Planning, P.A., the Borough's Architect on the Project, have reviewed the apparent lowest bid submission and recommend rejection of the apparent lowest bid and proposed contract for the Project by Whirl Construction, Inc., 194 Main Street, Port Monmouth, New Jersey 07758 because the bid proposal is approximately twenty percent (20%) higher than the Architect's estimate, some clerical mathematical errors were noted and specific line item information regarding pricing was not included; and,

WHEREAS, the Borough of North Plainfield finds that the apparent lowest bid proposal is not responsive to the Architect's estimate for the Project, contrary to the Local Public Contracts Law, *N.J.S.A.* 40A:11-1 *et seq.* as well, all other bids were considered excessive and non-responsive; and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby rejects the lowest apparent bid received for the Project in the amount of Four Hundred Seventy Thousand Eight Hundred and Fifty One Dollars and No Cents (\$470,851.00) by Whirl Construction, Inc., 194 Main Street, Port Monmouth, New Jersey 07758 be rejected as well as all other bids submitted in their entirety; and,

BE IT FURTHER RESOLVED that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute all necessary documents to memorialize the rejection of the lowest apparent bid for the Project by Whirl Construction, Inc. and all other bidders for this Project; and,

BE IT FURTHER RESOLVED that the rejection of such bid shall be consistent with all applicable laws, the Borough's bid documents and the bid proposal of Whirl Construction, Inc., for the Project known as the construction of a new public courtyard at the Vermeule Community Center. The Borough is authorized to explore all other legal avenues provided to it under the Local Public Contracts Law

RESOLUTION NO. 10-24-22-02b RESOLUTION OF THE BOROUGH COUNCIL REJECTING ALL BIDS FOR UPGRADES TO PUBLIC RESTROOMS

WHEREAS, the Borough of North Plainfield (hereinafter referred to as the "Borough") is in need of certain improvements for upgrades to public restrooms at the Vermeule Mansion, Vermeule Community Center and the North Plainfield Memorial Library (hereinafter referred to as the "Project"); and,

WHEREAS, the Borough solicited bids for the Project and the following two (2) bids were received:

WHEREAS, upon review of the bid of Salazar Associates, Inc., the apparent low bidder, by CTS Group Architecture & Planning, P.A., the Borough's Architect on the Project (the "Architect"), by letter dated September 16, 2022, a copy of which is on file in the office of the Borough Clerk, some clerical mathematical errors were noted and specific line item information regarding pricing was not included; and,

WHEREAS, furthermore, the review of the base bid of Salazar Associates, Inc., in the amount of Two Hundred Eighty Thousand Two Hundred Dollars and No Cents (\$280,200.00) was found to be approximately nineteen percent (19%) over the Architect's estimate for the Project of Two Hundred and Thirty Five Thousand Eight Hundred Dollars and No Cents (\$235,800.00); and,

WHEREAS, the Architect noted that while volatile market conditions may have resulted in higher prices which may be reflected in the prices set forth in the bid of Salazar Associates, Inc., the fact is that the apparent low bid is not fair nor reasonable, cannot be fairly evaluated and should be rejected; and,

WHEREAS, the next lowest and only other bid received from TC Landscape Construction Group in the amount of Four Hundred and Thirteen Thousand Dollars (\$413,000.00) was more than One Hundred and Fifty Thousand Dollars (\$150,000.00) over the Architect's estimate; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esquire and the offices of Eric M. Bernstein & Associates, L.L.C., as well as CTS Group Architecture & Planning, P.A., the Borough's Architect on the Project, have reviewed the bid submissions and recommended rejection of the bid and proposed contract for the Project by Salazar Associates, Inc., 2226 Morris Avenue, Union, New Jersey 07083 because the bid proposal is approximately nineteen percent (19%) higher than the Architect's estimate and did not include specific line item information to fairly evaluate the bid; and,

WHEREAS, the Borough of North Plainfield finds that the bid proposal by Salazar Associates, Inc., is not responsive to the Architect's estimate or specifications for information for the Project, contrary to the Local Public Contracts Law, *N.J.S.A.* 40A:11-1 *et seq.*; and,

WHEREAS, the next lowest and only other bid received from TC Landscape Construction Group, 156 Grand Central Parkway, Bayville, New Jersey 08721 was more than One Hundred and Fifty Thousand Dollars (\$150,000.00) over the Architect's estimate and therefore was not under consideration:

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby rejects the apparent low bid received for the Project in the amount of Two Hundred Eighty Thousand Two Hundred Dollars and No Cents (\$280,200.00) submitted by A Salazar Associates, Inc., 2226 Morris Avenue, Union, New Jersey 07083; and,

BE IT FURTHER RESOLVED that the Borough Council hereby rejects the sole remaining bid of TC Landscape Construction Group, 156 Grand Central Parkway, Bayville, New Jersey 08721; and,

BE IT FURTHER RESOLVED that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute all necessary documents to memorialize the rejection of all bids for the Project; and,

BE IT FURTHER RESOLVED that the rejection of such bid shall be consistent with all applicable laws, the Borough's bid documents and the bid proposals of Salazar Associates, Inc., and TC Landscape Construction Group for the Project known as capital improvements for upgrades to public restrooms at the Vermeule Mansion, Vermeule Community Center and the North Plainfield Memorial Library. The Borough shall take all further action permitted under the provisions of the aforementioned Local Public Contracts Law.

RESOLUTION NO. 10-24-22-02c RESOLUTION OF THE BOROUGH COUNCIL APPROVING PAYMENT NO. 3 (FINAL) TO CMS CONSTRUCTION, INC. AND THE CLOSING OUT OF THE CONTRACT AND RELEASE OF RETAINAGE FOR CONTRACT 2021-01 FOR THE WEST END AVENUE SANITARY SEWER REPLACEMENT PROJECT.

WHEREAS, the Borough of North Plainfield previously awarded Contract No. 2021-01 for the 2021 West End Avenue Sanitary Sewer Replacement Project (hereinafter referred to as the "Project") to CMS Construction, Inc. (hereinafter referred to as the "Contractor"); and,

WHEREAS, Matthew Voelkel, P.E., C.M.E., C.P.W.M., of Mott McDonald, the Borough's Engineer for the Project, on behalf of the Borough, by letter dated October 18, 2022, a copy of which is on file in the Office of the Borough Clerk and made a part hereof, has reviewed the Contractor's submission for Payment No. 3 (Final) and Final Change Order No. 1 (Final); and,

WHEREAS, the original contract price was Three Hundred Fifty Five Thousand Four Hundred Twenty Five Dollars and No Cents (\$355,425.00), which has been adjusted by Final Change Order No. 1 decreasing the final contract amount by Nineteen Thousand Four Hundred and Fifty Three Dollars and Ninety Six Cents (-\$19,453.96) for a final Contract Price of Three Hundred and Thirty Five Thousand Nine Hundred Seventy One Dollars and Four Cents (\$335,971.04); and,

WHEREAS, the Contractor has submitted said Final Payment No. 3, adjusted by Final Change Order No. 1, in the total amount of Eighty Nine Thousand Eight Hundred Seventy Seven Dollars and Fifty Two Cents (\$89,877.52), plus the release of any and all of the Contractor's retained funds held by the Borough for the Project; and,

WHEREAS, in accordance with the Contract, the Contractor has submitted a one (1) year Maintenance Bond in the amount of Three Hundred and Thirty Five Thousand Nine Hundred Seventy One Dollars and Four Cents (\$335,971.04), with an effective date of September 1, 2022; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq. and the offices of Eric M. Bernstein & Associates, L.L.C. have reviewed the Borough Engineer's and the Contractor's submissions and accept same based on the recommendations of the Borough Engineer.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the request for Partial Payment No. 3 (Final) and Change Order No. 1 (Final) and the Closeout of Contract 2021-01 for the West End Avenue Sanitary Sewer Replacement Project is approved with CMS Construction, Inc., whose main offices are located at 521 North Avenue, Plainfield, New Jersey 07060, in the total amount of Eighty Nine Thousand Eight Hundred Seventy Seven Dollars and Fifty Two Cents (\$89,877.52), plus the release of any and all of the Contractor's retained funds held by the Borough for the Project, which Final Payment Request and Closeout request is incorporated herein by reference as if same was fully set forth within and payment for same is authorized to be made to the Contractor, without the need for any further action of this Borough Council; and,

BE IT FURTHER RESOLVED that Final Change Order No. 1 decreased the amount of the overall Contract by Nineteen Thousand Four Hundred and Fifty Three Dollars and Ninety Six Cents (-\$19,453.96) for a final Contract Price of Three Hundred and Thirty Five Thousand Nine Hundred and Seventy One Dollars and Four Cents (\$335,971.04), which final contract price is hereby approved; and,

BE IT FURTHER RESOLVED that this Resolution shall be subject to the Certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same; and,

BE IT FURTHER RESOLVED that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute any and all necessary documents to close out the Project and issue Payment No. 3 (Final).

RESOLUTION NO. 10-24-22-02d RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE MAYOR AND BOROUGH CLERK TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH MOTT MACDONALD FOR NATIONAL FLOOD INSURANCE PROGRAM COMMUNITY RATING SYSTEM 2022 ANNUAL RECERTIFICATION AND GENERAL PROGRAM ADVANCEMENT FOR THE BOROUGH OF NORTH PLAINFIELD

WHEREAS, the Borough of North Plainfield is in need of a Professional Engineer to provide certain services related to the National Flood Insurance Program Community Rating System 2022 Annual Recertification and General Program Advancement for 2022 (the "CRS Program"); and,

WHEREAS, Mott MacDonald, with a principal place of business located at 3 Paragon Way, Freehold, New Jersey 07728, is in the business of providing Engineering Services for general CRS Coordination and Oversight, Annual Recertification and Program Advancement for the CRS Program and submitted a proposal, dated September 16, 2022, for the 2022 CRS Program Annual Recertification services of the Borough of North Plainfield, Somerset County, New Jersey, a copy of

said proposal being maintained in the Office of the Borough Clerk and the contents of which are incorporated herein; and,

WHEREAS, the said proposal of Mott MacDonald includes an estimated budget of Thirteen Thousand Three Hundred and Ninety Dollars and No Cents (\$13,390.00) for the said 2022 CRS Program Annual Recertification services; and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council does hereby award said contract to Mott MacDonald, 3 Paragon Way, Freehold, New Jersey and authorizes the Mayor and the Borough Clerk to sign and/or execute a Professional Services Agreement with Mott MacDonald for the 2022 CRS Program Annual Recertification and related services in an amount not to exceed Thirteen Thousand Three Hundred and Ninety Dollars and No Cents (\$13,390.00) without the need for any further action of this Borough Council.

BE IT FURTHER RESOLVED that the award of this Contract shall be subject to the Certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same.

BE IT FURTHER RESOLVED that the award is made pursuant to and consistent with the Local Public Contracts Laws of the State of New Jersey.

RESOLUTION NO. 10-24-22-02e RESOLUTION AUTHORIZING THE BOROUGH OFNORTH PLAINFIELD TO ACCEPT A SUBGRANT AWARD OF THE FEDERAL FISCAL YEAR 2022 OF EMERGENCY MANAGEMENT PERFORMANCE GRANT AND EMERGENCY MANAGEMENT AGENCY ASSISTANCE

WHEREAS, the Borough of North Plainfield, Office of Emergency Management has been awarded State Homeland Security Grant Program Sub-grant AFN #97.042, Subgrant Award #FY22-EMPG-EMAA-1814 from the New Jersey Department of Law and Public Safety, Office of the Attorney General. The subgrant, consisting of \$10,000.00 Federal Award is for the purpose of enhancing the City's ability to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies; and

WHEREAS, the Borough of North Plainfield will use these funds to enhance your Emergency Management Program and that the funds will be used for Emergency Management purposes; and

WHEREAS, the award period is from July 1, 2022 to June 30, 2023; and

WHEREAS, the subgrant award incorporates all conditions and representations contained or made in application and notice of award; and

WHEREAS, the Borough of North Plainfield Office Emergency Management, designated by the New Jersey State Police, Office of Emergency Management, has submitted an Application for Subgrant Award that has been required by the said New Jersey State Office of Emergency Management.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of North Plainfield, in the County of Somerset, State of New Jersey:

- 1. That the Council accepts the award of the FFY22 Emergency Management Performance Grant Program (EMPG), Emergency Management Agency Assistance Subgrant (EMAA) in the amount of up to \$10,000.00 Federal Funds from the New Jersey State Police, Office of Emergency Management.
- 2. That the Chief Financial Officer and Director of Emergency Management are authorized to sign the appropriate subgrant award documents.

PUBLIC COMMENT:

Simone Way, 118 Myrtle Avenue, North Plainfield, indicated her dissatisfaction with property maintenance enforcement at her address.
