WHEREAS, February was chosen primarily because its second week coincides with the birthdays of President Abraham Lincoln who emancipated the slaves and Frederick Douglas, a prominent abolitionist; and,

WHEREAS, this year's Black History Month theme is "Black Resistance" exploring how African Americans have resisted historic oppression from the nation's earliest days; and,

WHEREAS, by resisting African Americans have achieved triumphs, successes, and progress such as the end of slavery, the dismantling of segregation, the increased political representation at all levels of government, the passage of Civil Rights Act of 1964, the opening of the Smithsonian National Museum of African American History in DC and the increased and diverse representation of Black experiences in media: now, therefore,

BE IT RESOLVED by the Council of the Borough of North Plainfield that February, 2023 be recognized as Black History Month; and, be it further resolved that this Governing Body endorses this year's theme intended to celebrate the fight and perseverance of our diverse Community.

WHEREAS, the award of this contract to the County, pursuant to <u>N.J.S.A.</u> 13:1E-99.14 is an exception to the bidding requirements as set forth in the Local Public Contracts Law, pursuant to <u>N.J.S.A.</u> 40A:11-5(2) and the Board of Public Utilities Somerset Waste Franchise for Somerset County.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby authorizes the Mayor and the Deputy Borough Clerk or designee, on behalf of the Borough, to sign and/or execute the Agreement received from the County of Somerset Department of Public works via letter dated December 27, 2022, for a period commencing January 1, 2023 through and including December 31, 2023. WHEREAS, the County of Somerset, Division of Transportation shall provide a detailed report to the Borough of North Plainfield no later than the fifteenth (15^{th}) day of each month. The report shall include the number of users, the number of service days, the number of trips and a description of the nature of the trips taken by North Plainfield residents. With the report, the County of Somerset, Division of Transportation shall provide a voucher and invoice for the services provided. Monthly payments shall be submitted by the Borough to the County by the tenth (10^{th}) calendar day of the following month; and,

WHEREAS, the terms of the Agreement shall run from January 1, 2023 through December 31, 2023; and,

WHEREAS, the Borough of North Plainfield shall comply with the notice and cancellation requirements to the residents as set forth in the Agreement, which is attached hereto.

WHEREAS, the Borough previously designated Region Nine UAW Housing Corporation ("RNHC"), a non-profit, Internal Revenue Code 501c(3) organization, as the Redeveloper for the development of low- and moderate-income family rental dwelling units on the Property to help fulfill the Borough's Third (3rd) Round affordable housing obligations and implement the Borough's adopted Housing Element and Fair Share Plan; and,

WHEREAS, RNHC proposed to develop up to twenty-four (24) units of affordable housing on Lots 2.02 through 2.13 and a portion of Lot 2.14 of the Property; and,

WHEREAS, RNHC has failed to meet the various milestones associated with its Redeveloper designation and is unable to meet the Borough's requirements and expectations for the redevelopment of the Property; and,

WHEREAS, the Borough has determined that it is in the best interest of the Borough to encourage the redevelopment of the Property in accordance with its requirements and expectations; and,

WHEREAS, the Borough has further determined that it is in the best interest of the Borough to de-designate RNHC as the Redeveloper for the Property and to find another Redeveloper who can best meet the Borough's requirements and expectations for the redevelopment of the Property.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey as follows:

- 1. The above recitations are incorporated herein as if set forth at length; and,
- 2. RNHC is hereby de-designated and removed as the Redeveloper for the Property.

BE IT FURTHER RESOLVED that the Mayor and Borough Clerk are hereby authorized to execute any and all documents and/or agreements necessary to effectuate this Resolution on behalf of the Borough, subject to review and approval of the Borough Attorney.

Seconded by Ms. Schaefer and on roll call carried unanimously.

REQUESTS FOR AGENDA ITEMS:

Mr. Merrill requested an update on the Food Bank.

PUBLIC COMMENTS:

Francine Gargano, 57 Willow Avenue, North Plainfield, voiced her concerns about the traffic violators throughout North Plainfield. She stated her outrage with over-crowding in and around her neighborhood, noting that the amount of on-street parking has increased exponentially. Park visitors continue to park illegally on the surrounding side streets and public urination is commonplace which is disgraceful.

Michael Haggerty, 320 Brook Avenue, North Plainfield, recalled having served as Mayor of North Plainfield from 1993 – 1996 and hiring Rich Phoenix as Deputy Borough Clerk. The speaker noted his alarm to learn that Mr. Phoenix took roll call on his own re-appointment resolution with all voting nay.

Diane Melendez, 24 Howard Street, North Plainfield, commented that she planned to sell her house due to the over-crowding, drug-dealing, traffic violators and illegal parking on her street.

Mark Kruszczynski, 48 Willow Avenue, North Plainfield, stated his concerns with the amount of parked vehicles on Rockview Terrace near the intersection of Greenbrook Road. He proposed permit parking for certain sections of the Borough.

COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS:

Ms. Miller thanked the residents in attendance for bringing forth their concerns that evening.

Ms. Given reported that the Board of Education had appointed Mark Kruszczynski as Board President and Amnet Ramos as Board Vice President. Carlie Dougherty was appointed as the liaison to the Council. They have begun strategic planning to accommodate the needs of the Borough.

Council Vice President Corzo thanked Ms. Garry for her hard work and dedication over the last few weeks.

Motion to adjourn by Ms. Miller, seconded by Ms. Schaefer and on voice vote carried unanimously.
