









- Ridewise visited elementary schools to talk about and practice crosswalk safety

- High School morning announcements for students include 7 Safety tips for walking to school











RESIDENCY



— Full-Time Residency and Truancy Officer ——

The Residency Officer will carry out investigations requested by school administration to substantiate or refute questionable residences in North Plainfield. Surveillance may require early morning, evening, and weekend hours to properly complete investigations. The successful candidate will initiate petitions to juvenile intake, attend family court as a liaison for the school district, and attend Board hearings when necessary to present results of residency investigations.

REGISTRATION



- Students entering Preschool must be four (4) years of age on, or before, October 15th of the school year.
- Students entering Kindergarten must be five (5) years of age on, or before, October 15th of the school year.

There are no exceptions to this Board of Education policy.

BIRTH CERTIFICATE:

A student's original birth certificate/passport must be presented at time of registration. A copy will be made for the school file.

PARENT/GUARDIAN IDENTIFICATION:

The parent or legal guardian must show identification with a photo. A copy will be made for the school file.

Proof of custody/guardianship (if applicable)

IMMUNIZATIONS AND RECENT PHYSICAL EXAMINATION:

The student's immunization record must be up to date. The record must show the month and year of each inoculation.

PROOF OF RESIDENCY:

All families must complete the Statement of Parent/Guardian Affirming Residency in the Borough of North Plainfield, NJ (NP REG. 0001a-0001b). Although this form does not have to be notarized, it does require the signatures of husband and wife if the parents are married.
